## The Faculty and Graduate Studies

Selecting the Faculty of Law at the Université de Montréal means choosing a tradition of excellence that has been rooted for more than 135 years in francophone North American territory. Training that is at once rigorous and marked by humanism enables graduates to pursue their career, equipped with the requisite knowledge and creativity to play a key role in legal and social contexts worldwide that are in a constant state of evolution.

The Bachelor of Laws program offers general studies in law, as well as preparatory courses for further graduate or specialized studies or for a range of professional practices. The Bachelor of Laws program provides comprehensive and diversified legal training, enabling students to embark either on a professional legal career or a career in which knowledge of the law constitutes a major asset.

Aside from training jurists—the majority of whom will join a professional order such as the Barreau du Québec or the Chambre des notaires du Québec—the Faculty has a longstanding tradition of training graduate students through an extensive offering of Master’s programs, or by means of Doctoral studies.
